- Non-Food Vendor spaces are \$175.00 for the first 25x25 Ft. and \$5.00 for each additional foot.
- Food Vendor spaces are \$275.00 for the first 25x25 Ft. and \$5.00 for each additional foot.
- Only Approved items will be sold by vendors.
- The first 3 employees are covered with the vendor fee, you are required to pay an entry fee for each additional employee.

Any returning vendor who would like to participate in the following year please return your application and deposit on or before April 1st of each year, with the remainder due by August 1st.

Your spot may be forfeited if application and payment is not received. New vendors please submit your application and deposit on or before July 1st, with the remainder due by August 1st. No application is guaranteed and will be reviewed. If applications are denied the deposit will be returned. Whenever possible we try to avoid duplicates, although there is no guarantee.

All applications and a 50% deposit must accompany the contract, which must be received no later than June 30th. The total remaining amount is required by August 1st.

This event is an Adult Event. No children under 21 on will be permitted on the premises, no Pets, and no fireworks. This will be strictly enforced.
